



You are invited to submit an entry for the Weald of Kent Steam Rally which is to be held at:

Little Engeham Farm, Bethersden Road, Woodchurch, KENT TN26 3QY on the 4<sup>th</sup> and 5<sup>th</sup> August 2018

Details of this event are as follows and if you intend to enter, please complete and return the attached entry form to the organiser by 30<sup>th</sup> June 2018.

The Weald of Kent Steam Rally is an opportunity for owners of engines and classic vehicles to showcase and enjoy a weekend of socialising and activities. We ask that your vehicle take part in the main parade each day.

Once the public have exited the show site on Saturday, there will be a road run in to Woodchurch for those wishing to enjoy a two mile return trip to a local public house. For those that wish to stay on site, the bar and refreshments will reopen from 19.00 hrs.

An area away from the main show area will be set aside for camping and caravans. Toilets and limited wash facilities will be available but please be aware that there will not be power points so please plan accordingly.

If you are bringing your vehicle by trailer please provide details in order that we can make sure there is space set aside for storage over the weekend. We understand that you may be planning your movements around other events so if you wish to bring your vehicle to the site earlier than the week before or leave it on site for more than a week after the event please let us know in advance.

Your vehicle must be insured, third party and public liability risks including use on rally fields, with a minimum indemnity of £2,000,000 any one occurrence. You will be required to produce documentary evidence that such cover is in force before entering the Rally Field. If you have any queries on this matter, please contact the Rally organiser who will be able to answer any questions regarding safety policy or insurance requirements:

I further declare that the driver(s) hold a driving licence of the appropriate class and will produce, if required, such a licence and that the driver(s) have read the NTET Traction Engine Code of Practice.

I agree to produce, on request, an Inspection certificate in accordance with the IEE Regulations for any electrical equipment (ie generators, wiring, appliances).

I agree to abide by the Code of Practice of the National Traction Engine Trust and the Society's written Statement of Safety Policy.

I agree to operate my exhibit during the Event and comply with the instructions of stewards. In the event of any dispute the Event Organisers decision is final.
